SPEAKER BIOGRAPHIES

Anne Anderson is Chair of the Board of Advisers of the Institute for the Study of Diplomacy in the Walsh School of Foreign Service at Georgetown University. She was Ambassador of Ireland to the United States from August 2013 to July 2017. She was Ireland's 17th Ambassador to the U.S. and the first woman Ambassador. In 2018, UN Secretary-General António Guterres appointed Ms. Anderson to the fifth Advisory Group to the United Nations Peacebuilding Fund. Before her assignment in DC, she served as Ireland's Ambassador to the United Nations in New York (2009–2013); Ambassador to France (2005-2009); Ambassador to the European Union, Brussels (2001-2005); and Ambassador to the United Nations, Geneva (1995-2001.) During her Washington assignment, Ambassador was particularly focused on further strengthening Ireland-US economic, trade and investment links; highlighting Ireland's interests in relation to reform of US immigration legislation; supporting US interest and engagement on key issues still to be fully addressed in Northern Ireland; and further deepening the vibrant cultural connections between the two countries. She has undertaken a wide range of responsibilities in her various assignments as Ambassador. Some highlights of her multilateral work include chairing the WTO Trade Policy Review Body (1996), the UN Commission on Human Rights (1999) and heading the Irish team in Brussels during Ireland's EU Presidency in 2004 (she was awarded European Voice "Diplomat of the Year" in recognition of her Presidency role). During her New York assignment, she oversaw a review of the UN Peace-building machinery and was tasked by the President of the General Assembly with facilitating preparations for the 2013 UN Special Event on the Millennium

Development Goals. As Ambassador to the UN, her particular focus was on development/human rights/gender equality issues. From her assignment in Brussels, she retains a keen interest in EU Affairs. As a former Ambassador in Paris, her involvement with France also continues. Ambassador Anderson was awarded an Honorary Doctorate by the National University of Ireland in December 2011 (Doctor of Laws) and by Fordham University in May 2017 (Doctor of Humane Letters). She received a bachelor of arts degree in history and politics from University College, Dublin, and a diploma in legal studies from Kings Inns, Dublin.

Anthony Clark Arend is Professor Government and Foreign Service and Chair of the Department of Government at Georgetown University. He served as Senior Associate Dean for Graduate and Faculty Affairs (later Vice Dean) in the Walsh School of Foreign Service from August 2015 until July 2018. He served as Director of the Master of Science in Foreign Service Program from 2008-2017. His research and teaching are in the fields of international law, national security law, international legal theory, and human rights. He has published seven books, including Legal Rules and International Society, International Law and the *Use of Force: Beyond the UN Charter Paradigm (co*authored), and Human Dignity and the Future of Global Institutions (co-edited). With Professor Christopher C. Joyner, he founded the Institute for International Law & Politics at Georgetown and served as co-director of the Institute from 2003-2008. His is a University Affiliate at the Center for National Security and the Law at the Georgetown University Law Center and has also served as an adjunct professor of law. He serves as a Faculty Liaison to the Georgetown Institute

for Politics and Public Service. He has served as Chair of the Main Campus Executive Faculty and Vice President of the Faculty Senate for the Main Campus. Prior to coming to Georgetown, he was a Senior Fellow at the Center for National Security Law at the University of Virginia School of Law. He has also served as an Articles Editor for the Virginia Journal of International Law. Dr. Arend is a Life Member of the Council on Foreign Relations and serves as a Senator on the Board of Governors of the Georgetown University Alumni Association. In April 2017, Arend received the John Carroll Award from the Georgetown University Alumni Association. This award "is conferred upon Georgetown alumni whose achievements and record of service exemplify the ideals and traditions of Georgetown and its founder" and is the highest honor given by the Alumni Association. Dr. Arend received a PhD and an MA in foreign affairs from the Department of Government and Foreign Affairs of the University of Virginia. He received a BSFS, magna cum laude, from the Walsh School of Foreign Service at Georgetown University.

John Bansemer is the Director of the CyberAI Project and Senior Fellow at Georgetown's Center for Security and Emerging Technology (CSET). In addition to his work at CSET, he is an adjunct professor at Georgetown University's Walsh School of Foreign Service. Prior to joining CSET, John served in a variety of cyber, space and intelligence positions within the U.S. Air Force before retiring as a Lieutenant General. His last role was serving as the Assistant Director for National Intelligence, Partner Engagement, within the Office of the Director of National Intelligence. Prior to that assignment, he served as the Deputy Chief, Central Security Service,

at the National Security Agency. He also held a variety of staff positions including on the Air Staff and the National Security Council staff. His joint experience includes serving as the director of intelligence at European Command. John holds a master's degree in computer science from James Madison University and was a national defense fellow at Harvard University. He received his BS in computer science and statistics from Roanoke College.

Barbara K. Bodine is Distinguished Professor in the Practice of Diplomacy and concurrent Director of the Institute for the Study of Diplomacy at Georgetown University. Prior to joining Georgetown University's School of Foreign Service, she taught and directed policy task forces and policy workshops on US diplomacy in the Persian Gulf region, including Iraq and Yemen for seven years at Princeton University's School of Public and International Affairs and served as Director of the School's Scholars in the Nation's Service Initiative, a fellowship program for students pursuing careers in federal service. Ms. Bodine's over 30 years in the U.S. Foreign Service were spent primarily on Arabian Peninsula and greater Persian Gulf issues, specifically US bilateral and regional policy, strategic security issues, counterterrorism, and governance and reform. Her tour as Ambassador to the Republic of Yemen, 1997-2001, saw enhanced support for democratization and increased security and counterterrorism cooperation. Ms. Bodine also served in Baghdad as Deputy Principal Officer during the Iran-Iraq War, Kuwait as Deputy Chief of Mission during the Iraqi invasion and occupation of 1990-1991, and again, seconded to the Department of Defense, in Iraq in 2003 as the senior State Department official and the

first coalition coordinator for reconstruction in Baghdad and the central governorates. Ambassador Bodine is the recipient of a number of awards, including the Secretary's Award for Valor for her work in Occupied Kuwait. She is a former member of the Board of Directors of the American Academy of Diplomacy, cochair of the International Forum on Diplomatic Training, an associate fellow of the Geneva Centre for Security Policy, and a member of the Council on Foreign Relations. A native of St. Louis, Mo., Ms. Bodine is a Phi Beta Kappa and magna cum laude graduate of the University of California, Santa Barbara in Political Science and East Asian Studies and earned her Master's at the Fletcher School of Law and Diplomacy. A recipient of distinguished alumni awards from both UC Santa Barbara and the Fletcher School, she is a Regent Emerita of the University of California.

Daniel Byman is a professor in the School of Foreign Service with a concurrent appointment with the Department of Government. He served as Vice Dean of the SFS undergraduate program from 2015 until 2020 and before that as director of Georgetown's Security Studies Program and Center for Security Studies from 2005 until 2010. He also leads at Georgetown team in teaching a "Massive Open Online Course" (MOOC) on terrorism and counterterrorism for EdX. Professor Byman is also a part-time Senior Fellow at the Center for Middle East Policy at the Brookings Institution. From 2002 to 2004 he served as a Professional Staff Member with the 9/11 Commission and with the Joint 9/11 Inquiry Staff of the House and Senate Intelligence Committees. Before joining the Inquiry Staff he was the Research Director of the Center for Middle East Public Policy at the

RAND Corporation. Previous to this, Professor Byman worked as an analyst on the Middle East for the U.S. government. He is the author of Road Warriors: Foreign Fighters in the Armies of Jihad (Oxford, 2019); Al Qaeda, the Islamic State, and the Global Jihadist Movement: What Everyone Needs to Know (Oxford, 2015); A High Price: The Triumphs and Failures of Israeli Counterterrorism (Oxford, 2011); The Five Front War: The Better Way to Fight Global Jihad (Wiley, 2007); Deadly Connections: States that Sponsor Terrorism (Cambridge, 2005); Keeping the Peace: Lasting Solutions to Ethnic Conflict (Johns Hopkins, 2002); and co-author of *Things Fall Apart*: Containing the Spillover from the Iraqi Civil War (Brookings, 2007) and The Dynamics of Coercion: American Foreign Policy and the Limits of Military Might (Cambridge, 2002). Professor Byman has also written extensively on a range of topics related to terrorism, international security, civil and ethnic conflict, and the Middle East. His recent articles have appeared in Foreign Affairs and Foreign Policy, as well as journals including Political Science Quarterly, Studies in Conflict and Terrorism, International Security, and Journal of Strategic Studies. He earned a BA from Amherst College and a PhD from the Massachusetts Institute for Technology.

Karoun Demirjian is a Fellow at the Institute of Politics and Public Service, McCourt School of Public Policy, Georgetown University during the fall 2022 semester. She is on the national security team at the *Washington Post*, where she covered intelligence, defense, and foreign policy on Capitol Hill before becoming a Pentagon correspondent. Her award-winning career has spanned three continents, including postings in the *Post's* Moscow bureau, a stint in the Middle East working for the *Associated*

Press, and over a decade covering Congress. She was a member of the Washington Post teams that won the 2022 Pulitzer Prize Gold Medal for Public Service and the 2018 Pulitzer Prize for National Reporting, and individually won or came in as runner up for the David Lynch Memorial Reporting Award for three years running as a Washington Correspondent for the Las Vegas Sun. She has been a frequent featured expert on television and radio outlets, including as a CNN political analyst, and is co-author of the book UNCHECKED: The Untold Story Behind Congress's Botched Impeachments of Donald Trump, publishing in October 2022. She has a BA in history from Harvard University and a master's in law and diplomacy from the Fletcher School at Tufts University. When not working, Karoun loves making music: previously, she moonlighted as a classical soprano, and still enjoys playing piano, bad guitar, and singing in a band.

Katharine M. Donato is the Donald G. Herzberg Professor of International Migration and former Director of the Institute for the Study of International Migration in the Walsh School of Foreign Service at Georgetown University. She has examined many research questions related to migration, including the economic consequences of U.S. immigration policy; health consequences of migration; immigrant parent involvement in schools in New York, Chicago, and Nashville; deportation and its effects for immigrants; the great recession and its consequences for Mexican workers; U.S. legal visa system; and refugee and migrant integration. Her first book, Gender and International Migration: From Slavery to Present, was co-authored with Donna Gabaccia and published by the Russell Sage Foundation in 2015. Several years later, together with Elizabeth Ferris, she co-authored a second

book, Refugees, Migration and Global Governance: Negotiating the Global Compacts, published by Routledge in 2019. Professor Donato has also co-edited 8 refereed journal issues and published more than 90 refereed journal articles and book chapters. Since 2015, she has received funding for collaborative projects from the Mexican Human Rights Commission, National Science Foundation, Russell Sage Foundation, and the GHR Foundation. Currently, she is the Principal Investigator on an RSF-funded project that examines the assimilation and mobility transitions of immigrant adults who entered the U.S. as an unaccompanied minor. She is also a co-PI on an NSF-funded project that examines how environmental stressors affect out-migration and the health of families in southwestern Bangladesh. Dr. Donato was a visiting scholar at the Russell Sage Foundation during the 2017-2018 academic year. Prior to joining the Georgetown faculty, she was on the faculty of Vanderbilt and Rice Universities. She has a BS in economics from the New York Institute of Technology-Manhattan Campus, an MSW from University of Wisconsin-Milwaukee, and an MA and PhD in sociology from Stony Brook University.

Mo Elleithee is the founding Executive Director of Georgetown University's Institute of Politics and Public Service, the first institute of its kind in the nation's capital. Before launching the institute in 2015, he spent two decades as one of the top communications strategists in the Democratic Party, most recently as Communications Director and chief spokesman of the Democratic National Committee. A veteran of four presidential campaigns, Mr. Elleithee was Senior Spokesman and Traveling Press Secretary on Hillary Clinton's 2008 campaign. He served as a senior advisor and

strategist for Senator Tim Kaine's campaigns for Governor and U.S. Senate, and has worked on numerous other statewide and local races in every region of the country. A frequent political commentator on television and radio, he was named a FOX News contributor in 2016. He was a founding partner of Hilltop Public Solutions, one of Washington's leading political consulting and public affairs firms. He's been recognized on Washington Life Magazine's "Power 100" list; as a "Top Influencer" by Campaigns & Elections Magazine; and featured on Washingtonian Magazine's "Guest List." Mr. Elleithee earned his undergraduate degree from Georgetown's School of Foreign Service, and an MA in political management from The George Washington University. He lives in Washington with his wife and two children, and can often be found at the Verizon Center (or on Twitter during the off-season) cheering on his beloved Hoya basketball team.

Robert Gallucci is Distinguished Professor in the Practice of Diplomacy at Georgetown University's Walsh School of Foreign Service. He previously served as U.S. Ambassador-at-Large and Special Envoy for the U.S. Department of State, focused on the non-proliferation of ballistic missiles and weapons of mass destruction. He was the chief US negotiator during the North Korean nuclear crisis of 1994 and served as Assistant Secretary of State for Political Military Affairs and as Deputy Executive Chairman of the UN Special Commission following the first Gulf War. Upon leaving public service, Ambassador Gallucci served as Dean of the School of Foreign Service at Georgetown University for 13 years before he became president of the John D. and Catherine T. MacArthur Foundation. He has a BA from Stony Brook University and an MA and PhD from Brandeis University.

Mark Giordano is Professor of Geography, Vice Dean for Undergraduate Affairs and Cinco Hermanos Chair in Environment and International Affairs in Georgetown University's Walsh School of Foreign Service. His research focuses primarily on the international political dimensions of water, agriculture and the environment. He teaches classes on those topics and others including the (in)famous Map of the Modern World. As part of his interest in the use of art and objects in international affairs education, he sits is on the Boards of The Kentler International Drawing Center, Brooklyn and the Mokuhanga Project Space, Walla Walla. Prior to joining Georgetown, Mark held multiple roles at the Sri Lanka based International Water Management Institute, winner of the Stockholm Water Prize (the "Nobel Prize for Water"). He earlier served as a trade economist and a combine mechanic. Mark has spent a substantial part of his professional life in Asia and Africa and is from a small town in the other Washington. He has a BA from Whitman College, an MS from University of Minnesota-Twin Cities, and a PhD from Oregon State University.

Joel Hellman became Dean of the Walsh School of Foreign Service at Georgetown University in July 2015 after 25 years working on some of the most complex issues of governance, conflict, and the political economy of development as both a scholar and practitioner. He served at the World Bank in many senior roles including Chief Institutional Economist; and as Director of the Center for Conflict, Security and Development in Nairobi, Kenya, where he led the Bank's engagement with the most challenging conflict-affected fragile and states around the world; and as Coordinator of the Bank's response in Indonesia after the devastating Asian tsunami. He was the Senior

Political Counselor at the European Bank for Reconstruction and Development in London, leading its political engagement and analysis on Russia, Central Asia, and Eastern Europe. As a scholar, Dr. Hellman was a political science professor focusing on the politics of economic reform at Harvard University and Columbia University. His numerous publications include "Governance Gone Local: does Decentralization Improve Accountability" with Jose Edgardo Campos (2005). Born and raised in Brooklyn, New York, he is a graduate of Williams College, where he majored in area studies. He has a PhD in political science from Columbia University and an MPhil from the University of Oxford in Russian and East European studies.

Rebecca Katz is a Professor and Director of the Center for Global Health Science and Security, and holds joint appointments in Georgetown University Medical Center and the Walsh School of Foreign Service. She teaches courses on global health diplomacy, global health security, and emerging infectious diseases in the Science, Technology and International Affairs, Security Studies, and Global Infectious Disease programs. Prior to coming to Georgetown in 2016, she spent ten years at The George Washington University as faculty in the Milken Institute School of Public Health. Since 2007, much of her work has been on the domestic and global implementation of the International Health Regulations as well as global governance of public health emergencies. She has authored over 100 peer reviewed manuscripts, and five books in addition to numerous op eds, blogs, white papers and book chapters. From 2004 to 2019, Dr. Katz was a consultant to the Department of State, working on issues related to the Biological Weapons Convention, pandemic influenza and disease

surveillance. She returned to the Department of State in January 2021 as a senior advisor on the global COVID-19 response and global health security. In 2019, Dr. Katz co-convened the first international scientific conference on global health security, bringing together over 900 participants from around the world to form a community of practice. Dr. Katz received her undergraduate degree from Swarthmore College, an MPH. from Yale University, and a PhD from Princeton University. She is a member of the Council on Foreign Relations.

Peter Krogh is retired and lives in Georgetown and on Nantucket Island (where he sometimes wins surfcasting fishing tournaments). He was, for fifteen years, Distinguished Professor of International Affairs at the Walsh School of Foreign Service of Georgetown University and, prior to that, Dean of the Walsh School for twenty-five years. He has been honored by the governments of Austria and Germany, by Georgetown University with an honorary degree and an endowed chair in his name, by the Fletcher School of Law and Diplomacy with its Outstanding Leadership Award, and, most recently, by the Jan Karski Educational Foundation with its Spirit of Jan Karski Award. The honors program of the Walsh School bears his name. While at Georgetown, Dr. Krogh moderated 225 PBS television programs on foreign affairs (one of which won an Emmy Award) that are now catalogued in the Dean Peter Krogh Digital Foreign Affairs Archives in the university's library. Dr. Krogh served on the board of the Carlisle Companies and on the boards of several mutual funds and multiple foreign affairs organizations. He has published numerous articles on international affairs and a trilogy entitled "From the Dean's

Chair: Reflections on World Affairs, American Foreign Policy and Diplomacy." A memoir of his Walsh School deanship has just been published under the title: "A Quarter Century Saga: The Resurgence of Georgetown's School of Foreign Service: 1970-1995." Most recently he has published a book entitled: The World's Westward March: Explorers, Warriors and Statesmen" based on a course he taught at Georgetown. Dr. Krogh is a graduate of Harvard University and of the Fletcher School of Law and Diplomacy where he received his Master's and PhD degrees.

Charles Kupchan is Professor of International Affairs in the School of Foreign Service and Department at Georgetown Government University, and Senior Fellow at the Council on Foreign Relations. From 2014 to 2017, Kupchan served as Special Assistant to the President and Senior Director for European Affairs on the National Security Council in the Obama White House. He was also Director for European Affairs on the NSC during the first Clinton administration. Before joining the Clinton NSC, he worked in the U.S. Department of State on the Policy Planning Staff. Previously, he was Assistant Professor of Politics at Princeton University. He is the author of No One's World: The West, the Rising Rest, and the Coming Global Turn (2012), How Enemies Become Friends: The Sources of Stable Peace (2010), The End of the America Era: U.S. Foreign Policy and the Geopolitics of the Twenty-first Century (2002), Power in Transition: The Peaceful Change of International Order (2001), Civic Engagement in the Atlantic Community (1999), Atlantic Security: Contending Visions (1998), Nationalism and Nationalities in the New Europe (1995), The Vulnerability of Empire (1994), The Persian Gulf and the West (1987), and

numerous articles on international and strategic affairs. Kupchan has served as a visiting scholar at Harvard University's Center for International Affairs, Columbia University's Institute for War and Peace Studies, the International Institute for Strategic Studies in London, the Centre d'Etude et de Recherches Internationales in Paris, and the Institute for International Policy Studies in Tokyo. During 2006-2007, he was the Henry A. Kissinger Scholar at the Library of Congress and was a Fellow at the Woodrow Wilson International Center for Scholars. During 2013-2014, he was a Senior Fellow at the Transatlantic Academy. He received a BA from Harvard University and MPhil and DPhil degrees from Oxford University.

Ellen Laipson is a member of the Board of Advisers of the Institute for the Study of Diplomacy in the Walsh School of Foreign Service at Georgetown University. She is the Director of the International Security Program at the Schar School of Policy and Government at George Mason University. She joined GMU after a distinguished 25-year career in government and as President and CEO of the Stimson Center (2002-2015). She serves on a number of academic and other non-governmental boards related to international security and diplomacy and is a weekly columnist for worldpoliticsreview.com. Her last post in government was Vice-Chair of the National Intelligence Council (1997-2002). She also served on the State Department's policy planning staff, the National Security Council staff, and the Congressional Research Service. A member of the Council on Foreign Relations, she also serves on the Advisory Councils of the International Institute of Strategic Studies and the Chicago Council on Global Affairs, and on the board of the Diplomacy Center Foundation.

From 2003 to 2015, she served on the board of the Asia Foundation. She was a member of the CIA External Advisory Panel from 2006-2009, President Obama's Intelligence Advisory Board from 2009-2013, and on the Secretary of State's Foreign Affairs Policy Board 2011-2014. Laipson has an MA from the School of Advanced International Studies, Johns Hopkins University and an BA from Cornell University.

Kristen Looney is an Assistant Professor of Asian Studies and Government at Georgetown University, where she teaches courses on Chinese and Comparative Politics. Her research is on rural development and governance. Her first book, Mobilizing for Development: The Modernization of Rural East Asia, was published with Cornell University Press in 2020. Through a comparison of Taiwan, South Korea, and China, the book shows that different types of development outcomes were realized to different degrees, at different times, and in different ways. It argues that rural modernization campaigns played a central role in the region and that divergent development outcomes can be attributed to the interplay between campaigns and institutions. The analysis departs from common portrayals of the developmental state as wholly technocratic and demonstrates that rural development was not just a byproduct of industrialization, as many studies have presumed. Dr. Looney has previously published her research in World Politics, The China Quarterly, The China Journal, and Current History. Her research has been supported by the Wilson Center, the Chiang Ching-Kuo Foundation, the National Science Foundation, the Fulbright-Hays Program, the Blakemore Foundation, and the Foreign Language and Area Studies Fellowships Program. She holds a BA from Wellesley College

in Chinese studies and Ph.D. in government from Harvard University.

Rodney D. Ludema is a Professor Economics, with a joint appointment in the Walsh School of Foreign Service and the Department of Economics. He is the Director of the Landegger Program in International Business Diplomacy (IBD) and Chair of the Department of Economics. Professor Ludema specializes in the area of international trade. His research interests include the political economy of trade policy, international trade bargaining, preferential trade agreements, trade and the environment, GATT rules and dispute settlement, and economic sanctions. He served as Chief Economist of the United States Department of State from 2014 to 2016, and as Senior International Economist in the White House Council of Economic Advisers, 2012-13. At Georgetown, he teaches international trade in the undergraduate, MSFS and PhD programs. He received his BA from Calvin College and his MA, MPhil and PhD degrees in economics from Columbia University.

Helen McNeill has been the consultant to the Georgetown Leadership Seminar since 2000. She also consults for other academic programs and international groups. From 1992 until 1999, she worked for the National Trust for Historic Preservation as the International Affairs Program Director at the Woodrow Wilson House and has also held posts at the Meridian International Center, the Environmental Film Festival, and at the Washington National Cathedral. She holds a BA from Rosemont College and an MA from the University of Pennsylvania, and studied at the University of Vienna.

Andrew Scobell is a distinguished fellow with the China program at the U.S. Institute of Peace. He is also an adjunct professor in the Asian Studies program at Georgetown University's Edmund A. Walsh School of Foreign Service. He focuses on U.S.-China relations, China's armed forces and defense policy and China's foreign relations with countries and regions around the world — with a particular emphasis on the Korean Peninsula, Taiwan, Hong Kong, Southeast Asia, South Asia, Central Asia, Africa and the Middle East. He previously spent more than 10 years as a senior political scientist at the RAND Corporation, where his research and publications focused on China and the Indo-Pacific. Prior to RAND, Scobell was an associate professor at the George H. W. Bush School of Government and Public Service and founding director of the China Certificate Program at Texas A&M University. From 1999 to 2007 he served as associate research professor in the Strategic Studies Institute at the U.S. Army War College. Dr. Scobell's research interests include authoritarianism, communism and communism, civil-military relations, patterns and processes of cooperation and conflict, the use of armed force, crisis management, coercive diplomacy, deterrence, grand strategy and military strategy. He has authored or co-authored two books, 30 reports and more than 40 journal articles. He has also edited or co-edited 20 volumes. His awards include the Donald Bren Chair in Non-Western Strategic Thought at Marine Corps University, the Silver Star Award at Texas A&M University, the John Madigan Award at the U.S. Army War College, the Victor Olorunsola Award at the University of Louisville. He has also been a foreign language and area studies fellow at Columbia University and a foreign affairs and national defense fellow at the Congressional Research Service. Dr. Scobell earned a doctorate from Columbia University, a master's from the University of Washington's Henry M. Jackson School of International Studies and a bachelor's from Whitman College. He was born and raised in Hong Kong.

James Seevers is Director of Studies at the Institute for the Study of Diplomacy (ISD) at Georgetown's Walsh School of Foreign Service. He directs ISD's professional education programs including the Georgetown Leadership Seminar (GLS), the Young Asian Diplomats program (with The Asia Foundation), and - for practitioners in Qatar and the Middle East -- the Executive Master's in Diplomacy and International Affairs (EMDIA), which he helped create in close collaboration with Georgetown in Qatar. He also runs ISD's programs for Georgetown's undergraduate and graduate students, including undergraduate certificate diplomatic in studies, the international negotiation lab for Georgetown in Qatar, and the student fellows in diplomacy. He oversees the teaching of ISD's visiting practitioners from the State and Defense Departments, leads an ISD team-taught graduate seminar on Diplomatic and Military Statecraft, and teaches at the undergraduate level on US foreign policy-making. Prior to joining the Institute in 2005, Mr. Seevers was a State Department career foreign service officer, gaining wide-ranging experience through his work on South Asia, Europe, Southeast Asia, Latin America, and Capitol Hill. He served as a political officer in Indonesia during its 1996-99 democratic transition, participated in U.N.led efforts to reunify Cyprus during 2001-03,

and worked from 2003-05 on enhancing the U.S.-India strategic partnership. He also has extensive Hill experience in the Senate and Congressional Research Service. Mr. Seevers is a graduate of Tufts University with a BA in international relations and earned an MA in law and diplomacy at the Fletcher School.

Casimir A. Yost is Senior Fellow at the Institute for the Study of Diplomacy, Walsh School of Foreign Service, Georgetown University. His recent courses include "Forecasting Global Trends: Implications for Grand Strategy," "War and Presidential Decision Making," and "U.S. and China: Decisions on War and Peace." Mr. Yost was an adjunct at the RAND Corporation from 2015-2017, where he wrote on strategic surprise. In 2018 the Institute for the Study of Diplomacy produced his monograph, Grand Strategy and Strategic Surprise. From 2009 to 2013 Mr. Yost served on the National Intelligence Council (NIC), where he directed the Strategic Futures Group and its predecessor, the Long Range Analysis Unit. He was responsible for leading a team of senior intelligence analysts in conducting integrated assessments of the strategic environment to identify emerging risks and opportunities for the United States. In 2013 he was awarded the National Intelligence Superior Service Medal. From 1994 to 2009, Mr. Yost was at Georgetown University, first as Director of the Institute for the Study of Diplomacy and Marshall B. Coyne Professor in the Practice of Diplomacy and then, for the 2008-2009 academic year, as chair of the International Relations and Security Concentration of the Master of Science in Foreign Service Program. He taught courses on U.S. foreign policy and co-chaired ISD's Schlesinger Working Group

on Strategic Surprise. He also directed, from 2001-2008, an annual leadership development program sponsored by the Director of Central Intelligence and, after 2005, the Director of National Intelligence. His previous positions include President of the World Affairs Council of Northern California, Executive Director of the Asia Foundation's Center for Asian Pacific Affairs, Foreign Policy Advisor to Senator Charles McC. Mathias, Jr. (R-MD), Staff Director for the Subcommittee on International Economic Policy of the Senate Foreign Relations Committee, and with the First National City Bank (Citibank) posted overseas. He is a graduate of Hamilton College and has a Master of Science in Foreign Service degree from Georgetown University. He is a member of the Council on Foreign Relations and on the Board of Directors of the American Ditchley Foundation and the Advisory Council of the Eurasia Foundation.
